## FORT CUSTER TRAINING CENTER SPECIAL DEER HUNTING SEASON (2010)

### GENERAL INFORMATION

1. Fort Custer will offer the public the opportunity to hunt deer on the Training Center during three hunt periods. These hunt periods will run concurrently with the 2010 Michigan Firearms Deer Season.
2. Participants will be selected by random drawing.
3. The three hunt periods for 2010 are:
  - Period 1 - November 20, 2010
  - Period 2 - November 21, 2010
  - Period 3 - November 27, 2010

### APPLICATION PROCESS - READ CAREFULLY

1. Each individual will submit only ONE application.
2. If you have a preference of **hunting area**, include that hunting area number in the appropriate box on the application. (this does not guarantee selection of area).
3. Applications must be mailed in a legal size (9 1/2" by 4") envelope.
4. A legal size (9 1/2" by 4"), self-addressed, stamped envelope must be enclosed with each application. This is used for the return results of the drawing.  
**NOTE: GROUP APPLICATIONS** - The group member whose address appears on the return envelope will be responsible for contacting the other group members with the drawing results. (Choose your leader wisely).
5. Applications for hunters age 10-16 must be on the same application of the hunting parent or guardian who will be escorting them in the field.
6. Groups of up to ten (10) hunters may apply on one application. If successful in the drawing, the group will be assigned the same hunt period and area.

7. A fee of **\$5.00** will be charged to **each** applicant and must be enclosed with the application. **The application fee must be paid by check or money order, made out to STATE OF MICHIGAN,**
8. The application fee is non-refundable.
9. Applications **MUST** be postmarked no later than **September 30, 2010**.
10. Successful applicants will be notified by return envelope by **October 15, 2010**.
11. If an applicant is not drawn for their first choice, an alternate hunt period (second choice if available) will be assigned.

**SUCCESSFUL APPLICANT INFORMATION**

1. **All successful applicants will be required** to attend an orientation session at Fort Custer Training Center.  
**Directions:** Enter through the Denso Rd. gate and follow the signs.
2. Orientation times and dates:

3. All successful applicants must bring a current **Drivers License or a 2010 Michigan Firearms Deer License** to the orientation. Failure to bring one of these items will result in the applicant not being registered to hunt at Fort Custer Training Center.
4. Orientation will provide a safety and security briefing, a map of the area, allow for questions and answers, access to the training areas for reconnaissance, and will register you to hunt.  
**Reconnaissance will be allowed only on the two orientation dates, and on**

**GENERAL HUNT INFORMATION**

**1. In order to be eligible to purchase antlerless permits over the counter, to be used only at Fort Custer Training Center, you must fill out the separate application on the last page of this packet. By filling out this application you will be entered into a lottery system to gain eligibility to purchase 1 antlerless permit to be used only at Fort Custer Training Center.**

2. Anyone not strictly adhering to the rules and regulations pertaining to hunting on Fort Custer Training Center will forfeit all current and future hunting privileges on the installation.

3. **BOW HUNTING:** Bowhunting will only be authorized in Training Areas 1 and 2. This bow hunt will be held on the same dates as the FCTC firearms special deer hunt periods. **All bow hunters will be required to have a firearm deer license, and must wear hunter orange during the hunt.** There will be 40 successful applicants for each hunt period. Applicants must **check the bow hunt box** on the application to be entered in the bow hunt lottery. An applicant that does not mark the bow hunting box on the application will be entered in the firearms drawing. All other application instructions are the same.

4. **Tree stands** will be allowed in the **bow hunt areas only**. Portable ground blinds may be used in all hunt areas **but must have a hunter orange top**. Tree stands and ground blinds will be erected and removed daily during the hunts. **Elevated stands are not allowed in the firearms hunting areas.**

5. Applicants can apply for only one type of hunting; bow or firearms. However, all successful applicants are also eligible to hunt with either bow or firearm on a standby basis, as openings are usually available during hunt periods 2 and 3 hunts.

7. Applicants will be automatically eligible to hunt during a two day black powder hunt in December (*dates to be announced at orientations*).

8. Crossbows may be used in the bowhunting areas only.

Notification of the results of this lottery will be published at the mandatory safety orientations.

**Antlerless permits can be purchased at any official DNR license vendor AFTER November 1.**
