You must be one of the following to be eligible to hunt

- 1) Veteran with a 100% disability or deemed individually unemployable by the USVA
- 2) Posses a permit from the Michigan DNR to hunt from a standing vehicle
- 3) Considered by the State of Michigan to be Legally Blind

Fort Custer Training Center in Battle Creek will be hosting a two day gun hunt (October 16 and 17) for whitetail deer for disabled individuals. Hunters must apply for this hunt by filling out the application below and sending it along with proof of eligibility (copy of letter from USVA showing 100% disability or individually unemployable, photocopy of MDNR permit to hunt from a standing vehicle, paperwork from the State of Michigan proving hunters status as Legally Blind) to.
